Lekolar Group has entered into an agreement to acquire Heutink, the leading supplier of learning content, materials and furniture on the Dutch education market. The company, with more than 100 years of expertise in education, is based in Nijverdal, the Netherlands. In addition to its strong Dutch market presence, Heutink serves over 80 countries worldwide with its iconic educational brands Nienhuis Montessori and Educo.

– Teaming up with Heutink represents a major milestone towards our ambition of becoming the European premier source of inspirational and sustainable solutions for creative and playful learning. Heutink is a market leader in the Netherlands with deep pedagogic insight, great products and high entrepreneurial drive and innovation.
