Buybacks of Shares in Enea During the Period November 13 – 17, 2023

During the period November 13 – 17, 2023, Enea AB (publ) has repurchased in total 33,024 own shares (ISIN: SE0009697220) within the framework of the authorization from the Annual General Meeting 2023 to repurchase own shares. The purpose of the repurchase program is to enable the company to adapt its capital structure to its capital needs over time, thereby contributing to increased shareholder value. The intention is that the repurchased shares will be withdrawn by resolution at upcoming Annual General Meetings.

The repurchases are part of the share buyback program of up to SEK 25 million that was announced on October 26, 2023. The program, which runs during the period October 27, 2023 – January 31, 2024, is being carried out in accordance with the EU Market Abuse Regulation (MAR) and Commission Delegated Regulation 2016/1052 (the so-called Safe Harbour Regulation). The shares have been repurchased as follows:

Following the above repurchases, Enea holds a total of 463,993 ordinary shares and all 243,000 outstanding series C shares, corresponding to a total of 706,993 shares, as of November 17, 2023. The number of outstanding shares, excluding the own shares, is 21,151,238.
