By stepping into the role of Executive Chairman, I can dedicate more of my time to strategic initiatives and fundraising, while Johannes takes on the day-to-day leadership of the Company. Together, this structure enables us to fully leverage our respective strengths and ensure continued progress on the strategic and operational priorities that matter most. I am highly optimistic about H100's growth with this new leadership structure."
