

Region Gävleborg has decided to award Ortivus a contract on the delivery of semi-automatic defibrillators

Ortivus has been awarded a contract regarding the supply of equipment to Region Gävleborg's ambulance and hospital operations. The contract refers to the delivery of Ortivus' MobiMed Life, semi-automatic defibrillators. The order value is estimated to 4.0 MSEK and the contract duration is 2 years with a possible extension of another 1+1 years.

We are very pleased to announce that Region Gävleborg has decided to award Ortivus a contract for the supply of defibrillators to the region's pre-hospital and hospital care. The region, that has been Ortivus' customer for a long time, has been using MobiMed Monitor for patient monitoring and MobiMed ePR, electronic patient record, for several years. Through this award, the region expands with MobiMed Life and thus becomes one of the first Swedish regions to use Ortivus' entire product offering in its prehospital operations.

The contract covers 100 units of the Reanibex 300 model and 75 units of the Reanibex 100 model. Ortivus has exclusive distribution rights for Reanibex in the Nordics, UK and Ireland. Other eligible parties outside the region are Ljusdal municipality, Gästrike Rescue Service, Hudiksvall municipality and the Hälsingland Municipal Association.

"Historically, our collaboration with Region Gävleborg has been very successful and we are thankful for their continued trust in Ortivus and our solutions. With this award regarding MobiMed Life, the region will get a competitive solution." Says Stefan Ekblom, Senior Account Manager at Ortivus.

The contract will be signed after a period of 10 days from the date of the award, in accordance to the procurement regulations.
