

Codemill AB wins £1.2m, five year deal with Deutsche Bank UK

Umeå, Sweden, February 2nd, 2023 - Codemill AB (Nasdaq: CDMIL) has been awarded a five year contract, to supply and maintain a brand new multi-camera UHD recording, postproduction, Media Asset Management (MAM) and content delivery system, for the new UK Headquarters of Deutsche Bank in London. The agreement represents a total amount of £1.2m, half of that in 2023, and the rest for the following four years, and will be delivered in partnership with ProAV Ltd., a global audio visual (AV) systems integrator and support services provider.

Deutsche Bank employs over 8,000 people in the UK, and is one of the largest employers in the City. Deutsche Bank was founded in Berlin in 1870 to support the internationalisation of business and facilitate trade between Germany and overseas markets; the London branch was opened in 1873 as the first European office outside Germany.
