

Q-linea publishes supplementary prospectus in connection with rights issue

Q-linea AB (publ) ("Q-linea" or the "Company") publishes a supplement (the "Supplementary Prospectus") to the prospectus approved by the Swedish Financial Supervisory Authority and published on 10 January 2025 (the "Prospectus") regarding the ongoing rights issue (the "Rights Issue"). The Supplement Prospectus is part of and should be read together with the Prospectus.

The Supplementary Prospectus has been prepared because the Company, following the publication of the Prospectus, through a press release on 14 January 2025 announced the signing of the first US commercial contract for ASTar[®] instrumentation and through a press release on 14 January 2025 announced contract negotiations continue between Q-linea, Inc. and a large US reference laboratory, with an agreement anticipated in February 2025. Initial sites have been identified for early deployment of ASTar units. The press release has been published in its entirety on the Company's website www.qlinea.com.

The Supplementary Prospectus, which today, 27 January 2025, has been approved by the Swedish Financial Supervisory Authority, forms part of and should be read together with the Prospectus.
