Elin Vigrestad is the Deputy CEO for Operations and Maintenance at Mesta. Mesta is the market leader in road operations and maintenance in Norway and has the Norwegian Public Roads Administration (Statens vegvesen) and the country's 15 county municipalities as its largest customers. Mesta has been a leader in the use of Klimator in Norway and has been an important contributor to the company's development in recent years, both as a customer and as an owner.

Vigrestad has worked at Mesta for 6 years, first as Chief Operating Officer before moving to the commercial side in 2021.

Previously, she spent 14 years in various management roles at DNB, Norway's largest bank. She holds a degree in political science from the University of Oslo / Free University of Berlin. Vigrestad lives in Oslo and also holds several commitments in boards and committees related to the construction and transport sectors in Norway.
