THE GUARANTEE CONSORTIUM IS EXPANDED TO COVER APPROXIMATELY 62% OF THE ONGOING RIGHTS ISSUE IN ACARIX

Acarix AB ("Acarix" or the "Company") has entered into an agreement with an external investor on a so-called top guarantee in relation to the ongoing rights issue of units of approximately SEK 52.9 million (the "Rights Issue"). The top guarantee amounts to SEK 1 million, which means that the Rights Issue is currently covered by subscription undertakings and guarantee commitments amounting to approximately 62%. Due to the new top guarantee, the Company will prepare a supplementary prospectus which is expected to be published during week 51, 2022.

On 22 November 2022, the board of directors of Acarix resolved to carry out the Rights Issue, which was approved by the extra general meeting on 9 December 2022. Acarix has previously received subscription undertakings and so called bottom guarantee commitments within the framework of the Rights Issue amounting to approximately SEK 31.7 million, which corresponded to approximately 60% of the Rights Issue.

Acarix has entered into an agreement with an external investor regarding a so call top guarantee of SEK 1 million, which means that the Rights Issue is now covered by subscription undertakings and guarantee commitments amounting to approximately SEK 32.7 million, corresponding to approximately 62% of the Rights Issue. The subscription undertakings and bottom guarantee commitments covers the Rights Issue up to approximately SEK 31.7 million, while the new top guarantee of a maximum of SEK 1 million covers the Rights Issue as from approximately SEK 31.7 million up to the Rights Issue's highest amount.

For the top guarantee, a commission of 14% of the guaranteed amount in cash, or alternatively 14% of the guaranteed amount in the form of newly issued shares in the Company, is payable. The commission for the existing bottom guarantees amounts to either 12% of the guaranteed amount in cash, or alternatively 14% of the guaranteed amount in the form of newly issued shares in the Company.

The total costs for the guarantee commitments in the Rights Issue, including the top guarantee, amounts to approximately SEK 3.7 million provided that all guarantors choose to receive cash consideration.



Supplementary prospectus

Complete information regarding the top guarantee in the Rights Issue will be made available in a supplementary prospectus which will be prepared by the Company. The supplementary prospectus is expected to be approved by the Swedish Financial Supervisory Authority (Sw. *Finansinspektionen*) and published by the Company during week 51, 2022.
