# Fred Clark, Business Area President Region Americas, to retire from Thule Group in 2021 and announcement of new Corporate Management team set-up

Karl-Johan and Rickard will both become members of the company's Group Management as of October 1, as we take the global approach to Supply Chain and Product Development in the group to the next stage.

In connection with this change, Nis Gjendal, Vice President Global Purchasing, will report to Rickard Andersson and therefore not be part of the Group Management team.
