The program, which runs during the period May 10, 2024, up to and including the day before the Annual General Meeting 2025, is being carried out in accordance with the EU Market Abuse Regulation (MAR) and Commission Delegated Regulation 2016/1052 (the so-called Safe Harbour Regulation). The shares have been repurchased as follows:
