**Magle Chemoswed Holding AB ("Magle Group" or the "Company") today publishes a supplementary prospectus (the "Supplementary Prospectus") to the prospectus that was approved by the Swedish Financial Supervisory Authority and published on 2 December 2024. The Supplementary Prospectus is part of and must be read together with the prospectus.**

The Supplementary Prospectus has been prepared as Magle Group, on 5 December 2024, announced through a press release (i) that the Company's CFO Petra Jönsson Sjölin had decided to step down from her position as CFO and (ii) that the Company had appointed Aaron Wong as the new CFO of Magle Group.

The Supplementary Prospectus has been prepared in accordance with Article 23 of Regulation (EU) 2017/1129 and was approved by the Swedish Financial Supervisory Authority on 10 December 2024.
