

Flat has invested 3 MSEK in the AI company Perplexity

Flat Capital AB (publ) ("Flat") has invested approximately 3 MSEK in Perplexity AI ("Perplexity"), alongside other prominent investors such as IVP, Nvidia, New Enterprise Associates, Bessemer Venture Partners, Jeff Bezos and Elad Gil. Perplexity is a prominent AI-based search engine built on various Large Language Models (LLM) and has quickly reached approximately 10 million monthly active users. Flat invested 3 MSEK in the company during the fourth quarter of 2023, and as a result of the great interest in the capital round, Flat's allocation has now been confirmed at 3 MSEK.

Perplexity was founded in 2022 by Aravind Srinivas, Denis Yarats, Johnny Ho och Andy Konwinski, with combined experience from OpenAI, Google Brain, Meta AI, and DeepMind, among others. Since Perplexity's launch of one of the world's first fully functional conversational answer engine, about a year ago, the company has grown to 10 million monthly active users and has handled over half a billion questions in 2023.

As communicated in the year-end report, the investment of approximately 3 MSEK was made during the fourth quarter in 2023, in connection with the Series B round, Flat also indicated its interest in a larger allocation in Perplexity. The round was oversubscribed and Flat's investment amounts, as of today, to approximately 3 MSEK. However, Flat has a continued interest in further increasing its exposure to Perplexity.
