SinterCast adds Aktiespararna for commissioned research

[Stockholm, 5 April 2024] – SinterCast announces the appointment of Aktiespararna, Sweden's largest independent shareholder association, as a new analyst for commissioned research. In conjunction with the appointment, Aktiespararna has today published its initiation report. The comprehensive 29-page report has been distributed to more than 70,000 Aktiespararna members and is available on the Aktiespararna website: <u>https://www.aktiespararna.se/</u>. The initiation report provides a positive assessment of SinterCast and its growth opportunities. Indeed, Analysguiden's Head of Analysis, Mikael Näslund, ranked SinterCast as the number one investment opportunity among publicly listed Swedish companies for the combined 'Magic Rank' criteria of undervalued share price and high profitability. The report concludes that the main forecast scenario justifies a current share price of SEK 150 per share, representing 50% growth above the current market value.

The suite of services provided by Aktiespararna will include published analyst reports after each quarterly report and investor presentations at Aktiespararna Investor Day events. The dates for SinterCast presentations in 2024 have been set for 11 June and 26 November.
