

Goobit enters cooperation with new Bank

Goobit Group AB's (publ) subsidiary, Goobit AB, has entered into a partnership with Bank Frick regarding banking services. Bank Frick was founded in 1998, is based in Lichtenstein and already established 2018 banking services in blockchain.

Since the company's previous bank ended its commitment in December 2021, Goobit AB has worked intensively to find and establish a new banking partnership suitable for its services. The process has been more lengthy than we wanted and the company has had to seek outside Sweden's national borders to find a partner who, like ourselves, sees the possibilities within crypto and blockchain.
