

ContextVision AB: Transactions made under the buy-back programme

Oslo, 16 January 2026 – On 3 September, ContextVision AB (“ContextVision” or the “Company”) announced a share buy-back programme of up to NOK 10,000,000, with a maximum of 4,000,000 shares, in the period from 5 September 2025 to 5 March 2026.
