Flow Technology has signed an agreement to acquire 85% of the shares in Koka OY, which provides advanced measurement solutions and system integrations in the housing and water sectors. The company has an annual turnover of SEK 95 million and 24 employees.

Koka is based in Helsinki and is a leader in water metering in Finland. The company provides advanced measurement solutions and system integrations for water consumption that, together with user-friendly cloud services, simplify the monitoring and invoicing of water consumption.
