

REC SILICON - ANCHOR WAIVES OFFER CONDITION ON BOARD RECOMMENDATION TO PROVIDE THE NEW BOARD WITH FLEXIBILITY TO GIVE A STATEMENT OF THE OFFER

NOT FOR RELEASE, PUBLICATION OR DISTRIBUTION, IN WHOLE OR IN PART, DIRECTLY OR INDIRECTLY, INTO OR WITHIN CANADA, AUSTRALIA, SOUTH KOREA, NEW ZEALAND, SOUTH AFRICA, JAPAN, HONG KONG, OR ANY OTHER JURISDICTION IN WHICH THE RELEASE, PUBLICATION OR DISTRIBUTION WOULD BE UNLAWFUL

Reference is made to the stock exchange announcement published on 23 May 2025 regarding the publication of the offer document dated 22 May 2025 (the "Offer Document") and launch of the acceptance period for the board recommended voluntary all cash offer (the "Offer") by Anchor AS (the "Offeror") to acquire all issued and outstanding shares (the "Shares") in REC Silicon ASA (the "Company") at an offer price of NOK 2.20 per Share (the "Offer Price"). Reference is further made to the stock exchange announcement published on 24 June 2025 regarding the extension of the acceptance period under the Offer until 8 July 2025 at 16:30 (CEST) and the announcement on 26 June 2025 which confirmed that there will be no further extension of the offer period beyond 8 July 2025 and no increase in the Offer Price.

The board recommendation to accept the Offer was made on 19 May 2025 by the qualified members of the former board of the Company and there are strict restrictions on when the recommendation can be withdrawn in the closing conditions for the Offer and the transaction agreement entered into between the Offeror and the Company.

The annual general meeting in the Company held on 25 June 2025 resolved to elect new board members to replace all former board members. To allow the new board of the Company (the "**New Board**") to assess the Offer in the context of the current financial situation of the Company, the Offeror hereby waives the closing condition "Board Recommendation" as further set out in section 1.3 (ii) of the Offer Document. This also implies a corresponding waiver of the same restrictions under the transaction agreement. The New Board will thereby not be bound by the actions of the former qualified board members that gave the existing recommendation, but freely be able to conclude on whether it reconfirms or withdraws the recommendation of the Offer.

This stock exchange announcement has been reviewed by the Norwegian Financial Supervisory Authority in its capacity as takeover authority.

The Offer is still subject to the remaining conditions for closing as set out under section 1.3 of the Offer Document. The Offer is only capable of being accepted pursuant to the Offer Document, and the complete terms and conditions for the Offer (other than the amendments made pursuant to separate announcements) are included in the Offer Document.
