Looking towards 2026, Tangiamo has set a financial ambition of reaching consolidated revenues of 100–130 MSEK, driven primarily by growth within online segments, initial rollouts of Trustplay's iGaming products, and integration of Manserio's existing operations. The Company also anticipates further market traction across online and land-based segments, supported significantly by Manserio's continued market expansion.

These targets are underpinned by management's strategic roadmap to enter online gaming markets during H2-2025 and by leveraging extensive internal experience in these markets. Additionally, Tangiamo sees potential opportunities in emerging gaming segments such as the company's AI-powered live studio games and digital lottery initiatives, as well as Web3/crypto and sweepstakes markets.

Tangiamo previously communicated an ambition to reach cash flow neutrality by late 2025 or early 2026 and continues to actively pursue this goal. Achievement of this ambition will depend on commercial execution and the internal and external resources to support delivery and operational scaling.

"These are ambitious but realistic goals that reflect the progress we've made across our technology platform, our regulatory readiness, and our commercial pipeline. We are entering this next phase with strong alignment across the group and clear visibility into the steps needed to achieve our objectives," says Chris Steele, CEO of Tangiamo.
