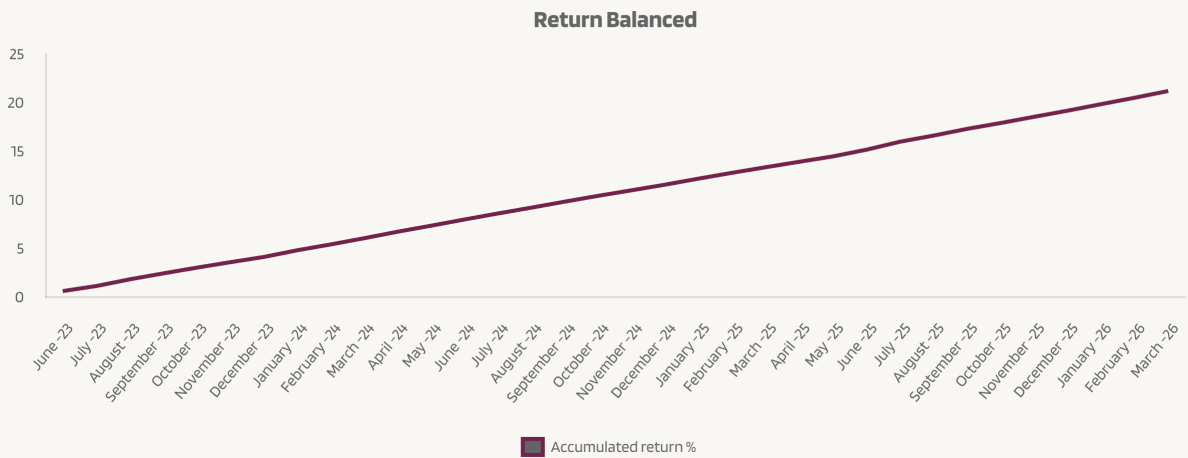


Returns and Exposure

Balanced, March 2026

Accumulated Return Since Inception

The average return for Balanced over a rolling 12-month period, including compound interest, amounts to 6.90%. Since the savings strategies were launched in June 2023, the accumulated average return including compound interest amounts to 21.21% for Balanced. The strategy has not had a single month with negative returns.



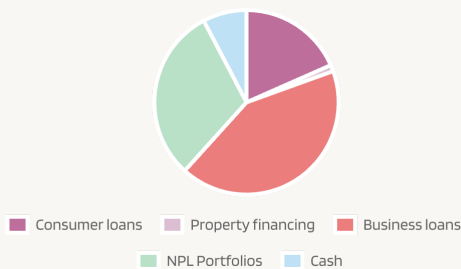
Monthly Returns
