

WPTG partner with Digital Generation to Accelerate Ransomware Prevention for South Africa's Largest Enterprises



WPTG will coordinate partner enablement, certifications and tiered support for enterprise deployments. DG will lead solution design, roll-out and ongoing managed services, with an initial focus on financial services, mining and resources, healthcare, and telecommunications.

- Speed to value. Agentless deployment and auditable controls, including ITsMine's "Red Button" data-neutralisation capability, compress time-to-protection and reduce blast radius without wholesale architecture change.
- Enterprise-grade delivery. DG brings end-to-end design, hybrid (on-prem/cloud) integration, and managed services, layered onto ItsMine Africa's enablement and escalation model.





• Scale and repeatability. DG serves as a flagship partner for South Africa, establishing a pattern WPTG can replicate in other priority markets.

"We've secured world-class ransomware prevention with ITsMine; now we're putting it in the hands of a partner that can land and scale it inside South Africa's biggest enterprises," said Johan Cloete, Head of Private Sector Business (Africa) at WPTG.
