

REC SILICON - ANCHOR ANNOUNCES THAT THERE WILL BE NO FURTHER EXTENSION TO THE OFFER PERIOD BEYOND 8 JULY AND NO INCREASE OF THE OFFER PRICE

NOT FOR RELEASE, PUBLICATION OR DISTRIBUTION, IN WHOLE OR IN PART, DIRECTLY OR INDIRECTLY, INTO OR WITHIN CANADA, AUSTRALIA, SOUTH KOREA, NEW ZEALAND, SOUTH AFRICA, JAPAN, HONG KONG, OR ANY OTHER JURISDICTION IN WHICH THE RELEASE, PUBLICATION OR DISTRIBUTION WOULD BE UNLAWFUL

Reference is made to the stock exchange announcement published on 23 May 2025 regarding the publication of the offer document dated 22 May (the "Offer Document") and launch of the acceptance period for the board recommended voluntary all cash offer (the "Offer") by Anchor AS (the "Offeror") to acquire all issued and outstanding shares (the "Shares") in REC Silicon ASA (the "Company") at an offer price of NOK 2.20 per Share (the "Offer Price"). Reference is further made to the stock exchange announcement published on 24 June 2025 regarding the extension of the acceptance period under the Offer until 8 July 2025 at 16:30 (CEST).

Summary

- The Company has stated that it will soon require additional financing either from Hanwha or from other sources of capital, none of which have yet been finalised or guaranteed (stock exchange announcement on 23 June 2025).
- Hanwha will provide no further loans to the Company without the Offer being completed.
- There will be no further extension to the offer period beyond 8 July and no increase of the NOK 2.20 per share offer price.
- More information about how to submit acceptance forms below.

As communicated by Hanwha Corporation and Hanwha Solutions Corporation (together, "Hanwha") in its letter to the Company dated 24 June 2025, Hanwha will not provide any further loans to REC Silicon if there are any changes to the composition of the board of the Company that is not supported by Hanwha and the Offer is not completed.

In a period where the Company needed continuity and stability at board level, both Hanwha and the Offeror deeply regret the outcome of the annual general meeting of the Company held on 25 June 2025, where a board not supported by Hanwha was elected.

As a consequence, Hanwha will provide no further loans to the Company without the Offer being completed.

In light of the Company's financial situation and its communicated reliance on support from Hanwha, both Hanwha and the Offeror are of the view that it is in both the Company's and shareholders' interest that the outcome of the Offer is concluded as soon as possible.

On this background, the Offeror has decided that it will not use its rights pursuant to section 1.4 of the Offer Document to extend the current acceptance period. Further, the Offeror has resolved that the Offer Price of NOK 2.20 per Share is its best and final offer. This means that the Offer under the current offer period (ending on 8 July 2025 at 16:30 (CEST)) is the last and final Offer to the shareholders of the Company.

The Offer is only capable of being accepted pursuant to the Offer Document, and the complete terms and conditions for the Offer (other than the amendments made pursuant to the separate announcement) are included in the Offer Document.
