WPTG signs AI contract in UAE worth SEK 33 million over 2 years

Stockholm, Sweden – 2025-10-02 - White Pearl Technology Group AB (WPTG) announces it has agreed to sell its AI platform Nexus AI to AumAven Technologies, a Dubai-based IT consultancy serving enterprise and public sector clients across the United Arab Emirates.
