

# Flat invests 22 MSEK in SpaceX

Flat Capital AB (publ) ("Flat") invests approximately 22 MSEK in SpaceX, or Space Exploration Technologies Corp, which designs, manufactures and launches some of the world's most advanced rockets and spacecraft. SpaceX was founded in 2002 by CEO Elon Musk to revolutionize space transportation with the vision of enabling humans to live on other planets. Flat's investment is made through a Special Purpose Vehicle ("SPV") and involves market-based management costs. The investment of 22 MSEK is made through two sub-investments of which approximately 18 MSEK has been completed.

SpaceX, since its founding by CEO Elon Musk, has been dedicated to revolutionizing and leading the space industry with a strong focus on innovation and cost efficiency. As of August 2024, SpaceX has launched 376 rockets, of which 341 have landed successfully and 310 have been successfully reused. SpaceX also offers internet services through satellites via its Starlink brand.

Flat's investment in SpaceX is conducted through a so-called SPV, a structure that involves certain administrative costs and a profit sharing mechanism upon realization of any profits. The costs of the SPV structure are considered to be in line with market practice and will not substantially affect Flat's total costs. Annual running costs are estimated to be less than 0.06% of the net asset value at the time of investment.
