## Buybacks of shares in Enea during November 29 – December 3, 2021

During the period November 29 – December 3, 2021, Enea AB (publ) has repurchased in total 3 800 own shares (ISIN: SE0009697220) as part of the share buyback program initiated by the Board of Directors to secure delivery of shares in the share related incentive program.

The share buybacks form part of the buyback program, which Enea announced on July 16, 2021. The share buyback program, which runs between July 19, 2021 to March 31, 2022, is being carried out in accordance with the EU Market Abuse Regulation (MAR) and Commission Delegated Regulation 2016/1052 (the so-called Safe Harbour Regulation). Shares in Enea have been repurchased as follows:

All acquisitions have been carried out on Nasdaq Stockholm by DNB on behalf of Enea. Following the above acquisitions, Enea's holding of own shares amounts to 116 688 as of December 3, 2021. The total number of shares in Enea, including the own shares, is 21,615,231, and the number of outstanding shares, excluding the own shares, is 21,498,543.
