## **Sara Diez Jauregui is proposed as new Board member of RevolutionRace**

**The Nomination Committee has today announced the proposal to elect Sara Diez Jauregui as new Board member. Sara Diez Jauregui does not hold any shares in RVRC. Sara Diez Jauregui is considered to be independent in relation to the company, the executive management and the company's major shareholders.
