BIMObject, the Building Product Information Platform, today announces its intent to strategically acquire GreenMetrica AB and Lumea AI Plattform AB, as part of BIMObject's transformation into an AI-powered platform company. Building upon a well-established partnership, this acquisition marks a logical next step for both organizations. By joining forces, BIMObject will gain key AI talent in-house and an AI platform, further enhancing its product offerings.

The combination of BIMObject's industry knowledge with GreenMetrica's deep AI expertise is anticipated to result in more AI-enhanced product offerings and increased development efficiency. The partnership has so far resulted in the development of AI-based features in EandoX, our Environmental Product Performance software.

"This represents an exciting opportunity and we look forward to welcoming the team to the company after a long-standing collaboration," said Sofia Hylén, interim CEO at BIMObject. "We believe that by combining our strengths and resources, we can create a more powerful and competitive entity that is better positioned to serve our clients and capitalize on market opportunities."

GreenMetrica is a specialist consultancy focused on agentic AI and the automation of sustainability workflows, helping organizations turn unstructured data into actionable insights. Lumea AI Plattform AB provides the underlying AI platform that powers these solutions. Together, they offer a capability of advanced AI infrastructure, forming a strong foundation for future product development.

Mikael Tellhed, Co-founder at GreenMetrica, added, *"We are thrilled about the prospect of joining forces. This will enable us to deliver superior value to the construction industry and beyond by leveraging BIMObject's market position and our AI technology."*

The purchase price is intended to be paid primarily with newly issued shares in BIMObject and the value at today's share price is approximately SEK 13 million. Completion is expected during the summer, subject to customary due diligence and final agreements.
