

From 26 January – 30 January 2026 Kambi Group plc purchased its own shares (ISIN: MT0000780107) as shown below. Following these latest purchases, Kambi Group plc holds 681,153 of its own shares as of 30 January 2026. The total number of shares in Kambi Group plc is 27,709,944.
