- 2000: The product requires a lot of manual labour and our competitor has solved the high labour cost by establishing production in Poland. We wanted a Norwegian product to be produced in Norway and decided to build a factory in Askim, Norway. (300 square meters)
- 2010: Built new warehouse (500 square meters)
- 2012: Became preferred and approved supplier to Coca-Cola Enterprises.

- 2016: Extended the entire factory with cold storage, production and warehouse (total building 3 000 square meters).
- 2017: Split the business model in three segments:
 - Bakery
 - Stock services
 - Pre-pack services
