Major Nocom initiative in business integration – close collaboration entered with American TIBCO

Nocom AB (publ) and TIBCO Software Inc (Nasdaq: TIBX) have signed a collaborative agreement relating to TIBCO's world-leading software for integration. Collaboration entails that Nocom will complement its Swedish sales and marketing organization with TIBCO's solutions. These are well-suited to Nocom's consultation and service offerings. With TIBCO's infrastructure software, companies' systems and processes are coordinated in real-time – both internally and externally – for customer relationship management (CRM), electronic commerce between businesses (B2B) and process automation, for example.

Nocom has the experience and profile needed for successful projects that encompass both products and services”, says Jimmy Sköldberg, TIBCO, Regional Director Nordic. “Collaboration will significantly strengthen both our own and Nocom's position on the market.”

Both Nocom and TIBCO have been active in the market for many years and integration solutions is one of the IT areas that is judged to have the greatest growth potential. The analysis firm Gartner Group estimates that the market for integration solutions will be about \$19 billion for the coming four years. * Together with IBM, TIBCO is the leading supplier on this market. TIBCO's turnover for the third quarter 2001 was USD 75,200,000. Among its Swedish customers are SAS, Telia and Hi3G.

“We see collaboration with TIBCO as strategically important and it will further strengthen our position as a supplier of advanced IT solutions,” says Nocom's CEO Stefan Skarin.

“Through collaboration with TIBCO, Nocom will be competing with companies such as IBM for market shares in business integration. We will take a leading position in this sector.”
