Year-End Report Nocom AB (publ) Summary

- Net sales during 1999 amounted to SEK 187.5 million (159.8), an increase of SEK 27.7 million, or 17%.
- Net sales during the fourth quarter increased by 26% and amounted to SEK 72.8 million (57.9).
- The number of employees increased by 50% during 1999, from 97 to 146.
- Operating income before depreciation amounted to SEK 7.0 million (10.5).
- Income before tax amounted to SEK 1.0 million (10.6).

Addition of consultancy and deployment services, which complement the previous software operations, have been given priority during 1999.

Nocom is developing into a supplier of complete solutions for e-commerce over the Internet and over mobile networks.

Nocom has achieved a leading position on the emerging market for mobile solutions during 1999, as a direct result of the collaboration with Nokia and Europolitan. Several strategic WAP contracts have been signed with customers, primarily with companies in the travel industry and the finance industry.

WAP Direct[®], a service for rapid and secure WAP traffic, has been developed in collaboration with Europolitan.
