Business with companies in the automotive, semiconductor and medical technology industries also lies within Jörgen's area of responsibility. He lives in Linköping and has an MSc from the KTH Royal Institute of Technology.

"I am really looking forward to taking over the leadership of XMReality," says Jörgen Remmelg. "Although the company in its current form is relatively young, its customer base is strong and consists of many of the world's leading industrial players. XMReality has a strong product and a good offering that is used in fully 42 countries. Together with the company's board of directors, employees, and existing and new customers, I am convinced that we will generate good growth and additional value".
