

SHARE SUBSCRIPTIONS BASED ON THE RESOLUTION BY NANOFORM FINLAND PLC'S ANNUAL GENERAL MEETING 2025 ON REMUNERATION OF THE BOARD OF DIRECTORS

Helsinki, Finland – A total of 138 617 Nanoform Finland Plc's (the "Company" or "Nanoform") new shares has been subscribed for by the members of the Board of Directors of the Company. The shares are issued as part of remuneration of the members of the Board of Directors in accordance with the resolution by the Company's Annual General Meeting April 15, 2025 (the "AGM"). As noted in the AGM, the share price 0,95 euros corresponds to volume-weighted average share price over ten (10) trading days following the publication of the interim report of the Company for 1 January 2025 – 31 March 2025 (the "Q1 Report"). The Q1 Report was published on May 20, 2025.

The entire subscription price of EUR 132,000 for the share subscriptions will be entered in the Company's reserve for invested unrestricted equity. The shares subscribed for are expected to be registered in the Trade Register on or about 7 July, 2025, as of which date the new shares will establish shareholder rights and the total amount of shares in the Company will be 85,669,853. The shares will be traded on the NASDAQ Helsinki Plc's First North Growth Market Finland marketplace together with the old shares on or about 7 July, 2025.
