Repurchases of shares during week 3, 2026

Between 12 January and 16 January 2026 Attendo AB (LEI code 549300KEJDL2FNITUW65) ("Attendo") has repurchased in total 207,643 own shares (ISIN: SE0007666110) as part of the repurchase program initiated by the Board.

The repurchases form part of the repurchase program of a total maximum amount of SEK 200,000,000 that Attendo announced on 24 October 2025. The repurchase program, which runs between 3 November 2025 and 4 February 2026, is being carried out in accordance with the Market Abuse Regulation (EU) No 596/2014 and the Commission Delegated Regulation (EU) No 2016/1052.
