## \$KOBAN launch – community pre-sale starting

Fragbite Group AB's (publ) ("Fragbite Group") subsidiary WAGMI Ltd. will start the public launch of \$KOBAN with a community pre-sale on 14 April. As previously communicated, the public launch of the \$KOBAN token is scheduled for H1 2025, with the following three main steps:

- 1. Community pre-sale
