The company offers a full range of services in landscaping, gardening services, infrastructure and maintenance of outdoor environments. The company has approximately 45 employees and is headquartered in Narvik, with additional offices in Tromsø and Harstad.

Markussen is a fantastic company that is well known for carrying out high-quality projects, largely thanks to the goal-oriented work that Florian Aschwanden and his colleagues have put in around digitalization, quality assurance, sustainability, and the environment.
