Íslandsbanki hf.: Upcoming covered bond auction 18 June

Íslandsbanki will offer two covered bonds two series on Wednesday 18 June 2025. The series ISB CB 31 and ISB CBI 32 will be offered to investors.

The bonds will be offered in a single-price auction, where all accepted offers will be awarded at the highest accepted yield. Íslandsbanki reserves the right to accept or reject offers in part or in whole.

In connection with the auction, a covered bond exchange offering will take place, where holders of the series ISB CBI 26 can sell the covered bonds in the series against covered bonds bought in the above-mentioned auction. The clean price of the series ISB CBI 26 is predefined at 98.52.

Expected settlement date is 25. June 2025.
