

# Xbrane announces intention to carry out a directed share issue

Xbrane Biopharma AB (publ) ("Xbrane" or the "Company") hereby announces its intention to carry out a directed share issue of approximately SEK 150 million to institutional investors through an accelerated book-building procedure, pursuant to the authorization granted by the annual general meeting held on 5 May 2022 (the "Directed Share Issue").

The Directed Share Issue is intended to be resolved by the board of directors pursuant to the authorization granted by the annual general meeting held on 5 May 2022 and is intended to be carried out with deviation from the shareholders' preferential rights. The Directed Share Issue will be directed to Swedish and international institutional investors. The price of the new shares in the Directed Share Issue will be determined through an accelerated book-building procedure, for which the Company has appointed Kempen & Co and Pareto Securities AB as Joint Global Coordinators and Joint Bookrunners. The accelerated book-building procedure will commence immediately after publication of this press release and end before commencement of trading on Nasdaq Stockholm on 19 October 2022. The book-building procedure may, at the discretion of the Company, close earlier or later and may be canceled at any time.

The Company's Board of Directors has made an overall assessment and carefully considered the possibility to raise capital through a preferential rights issue, but considers that it, for example, would entail a risk that the Company cannot provide for its capital needs and at the same time maintain an optimal capital structure. As the Directed Share Issue among other things, will (i) provide the Company with significant and reputable long-term shareholders, which diversifies and strengthens the Company's shareholder base, (ii) further strengthen the Company's financial position to enable the Company to continue executing on developing and commercialization of biosimilars, (iii) be conducted in a more time efficient way and at a lower cost and with less complexity than a preferential rights issue, and (iv) ensure a strong balance sheet in the current market situation, the Board of Directors' overall assessment is that the reasons for carrying out the Directed Share Issue overweigh the reasons that motivate the main rule that share issues are to be made with preferential rights for the shareholders

The purpose of the transaction is to finance the preparations for commercialization in Europe and the continued development of preclinical programs. More specifically, the net proceeds from the transaction are intended to finance the following activities:

- i. Build-up of Xlucane™ (Ximluci®) launch volume and inventory in preparation for commercialization in Europe (approximately 60%)
- ii. Progression of BIIB801 program until completion of pre-clinical development (approximately 10%)
- iii. Continued development of oncology portfolio (approximately 20%)
- iv. General corporate purposes (approximately 10%)



In connection with the Directed Share Issue, the Company has, subject to customary exceptions, agreed to a lock-up undertaking on future share issuances for a period of 180 days following completion of the Directed Share Issue. Members of the Company's board of directors and management, have, subject to customary exceptions, agreed to not sell their shares in the Company for a period of 180 days after the date of registration of the shares issued in connection with the Directed Share Issue with the Swedish Companies Registration Office. Existing shareholder STADA Arzneimittel AG has, subject to customary exceptions, agreed to not sell their shares in the Company for a period of 90 calendar days after the date of registration of the shares issued in connection with the Directed Share Issue with the Swedish Companies Registration Office.
