Reference is made to the stock exchange announcement published on 23 May 2025 regarding the publication of the offer document dated 22 May (the "**Offer Document**") and launch of the acceptance period for the board recommended voluntary all cash offer (the "**Offer**") by Anchor AS (the "**Offeror**") to acquire all issued and outstanding shares (the "**Shares**") in REC Silicon ASA (the "**Company**") at an offer price of NOK 2.20 per Share (the "**Offer Price**"). Reference is also made to subsequent stock exchange announcements related to the Offer.

The Offeror announced on 11 July 2025 that the Offeror had received acceptances under the Offer for 184,839,587 Shares, corresponding to approximately 43.94% of the issued and outstanding share capital and voting rights of the Company.

The Offeror hereby announces that the Offer has been completed and that settlement of the Offer has been made pursuant to the terms set out under section 1.8 of the Offer Document. For every Share for which the Offer has been lawfully accepted, the Offeror has paid a consideration of NOK 2.20. The receiving agent has registered payments of the Offer Price to shareholders who have accepted the Offer in accordance with the procedures set out in section 1.8 of the Offer Document. Norwegian shareholders with a known bank account are expected to receive the settlement amount on their respective bank accounts within today, 14 July 2025.

Further, the Offeror hereby announces that it will launch a mandatory offer within the deadline set out in section 6-10 (1) of the Norwegian Securities Trading Act.
