Ziccum's rights issue registered – conversion of BTU into shares and warrants

Ziccum AB (publ) ("Ziccum" or the "Company") has completed a rights issue of units, consisting of shares and warrants of series TO 6, where the subscription period ended on 10 December 2024 (the "Rights Issue"). The Rights Issue was registered with the Swedish Companies Registration Office on 27 December 2024. The last day of trading in paid subscribed units ("BTU") will be 3 January 2025. The record date is 8 January 2025, after which the BTU's will be converted into shares and warrants of series TO 6 on 10 January 2025. Shares and warrants are expected to be distributed to the investors' VPC accounts/custody accounts on 10 January 2025.

The Rights Issue was registered with the Swedish Companies Registration Office on 27 December 2024. The last day of trading in BTU's will be 3 January 2025. The record date is 8 January 2025, after which the BTU's will be converted into shares and warrants of series TO 6 on 10 January 2025. Shares and warrants are expected to be distributed to the investors' VPC accounts/custody accounts on 10 January 2025.
