ADDvise Group announces intention to carry out a directed new share issue of approximately SEK 100 million

ADDvise Group AB (publ) ("ADDvise" or the "Company") hereby announces intention to carry out a directed new issue of shares of series B of approximately SEK 100 million directed to Swedish and international institutional investors (the "Directed New Share Issue").

The Directed New Share Issue is intended to be carried out with deviation from the shareholders' preferential rights pursuant to the authorization granted to the Board of Directors by the annual general meeting on April 23, 2021. ADDvise has engaged Pareto Securities AB ("Pareto Securities") to investigate the possibilities to conduct a Directed New Share Issue through an accelerated bookbuilding procedure.

The subscription price for the shares in the Directed New Share Issue will be determined through an accelerated bookbuilding procedure which will begin immediately after publication of this press release and end before the commencement of trading on Nasdaq First North Premier Growth Market on March 15, 2022. The bookbuilding procedure may, at the discretion of the Company or Pareto Securities, close earlier or later and may be cancelled at any time. The Company intends to use the net proceeds from the Directed New Share Issue to finance future acquisition opportunities in accordance with the Company's communicated growth strategy and general corporate purposes.

The reason for the deviation from the shareholders' preferential rights is also to perform a capital raise in a time and cost-effective manner and to raise capital at favourable conditions for the Company's continued expansion, as well as to diversify the shareholder base with Swedish and international institutional investors. The Board of Directors has carefully considered the possibility to carry out a rights issue and concluded that a directed issue is most favourable for the Company and its shareholders in this case due to the reasons set out above. Given that the subscription price in the Directed New Share Issue will be determined through an accelerated bookbuilding procedure, it is the board of directors' assessment that the subscription price will be determined at market terms and conditions.

In connection with the Directed New Share Issue, the Company has undertaken, subject to customary exceptions, not to issue additional shares for a period of 6 months after the announcement of the outcome of the Directed New Share Issue. Shareholding board members, shareholding senior executives and the principal shareholder Per-Arne Åhlgren have undertaken, subject to customary exceptions, not to sell any shares in ADDvise for a period of 90 calendar days after the announcement of the outcome of the Directed New Share Issue.
