## **Strong C-RAD presence at Nordic radiotherapy meetings**

**C-RAD AB with its three fully owned subsidiaries is all active in the field of radiation therapy. The company attended and exhibited at the annual physicist meeting DSMF in Odense, Denmark, May 15-16 and the annual Finnish Radiation Therapy Meeting held in Helsinki, May 14-15. The Sentinel laser scanner system was exhibited and important meetings were held with the major customers in respective country. The first two Sentinel laser scanners have also recently been installed at the Docrates clinic in Helsinki Finland.**
