Obducat receives order for an Eitre 8[®] NIL system from INL in Portugal

OBDUCAT AB (publ) subsidiary Obducat Technologies AB, a leading supplier of lithography solutions based on nanoimprint lithography (NIL), has received a purchase order for a Eitre 8 NIL system from INL (International Iberian Nanotechnology Laboratory), located in Portugal. The order value amounts to 350.000 EUR.

The Obducat nanoimprint system will be installed in the INL clean room facilities. With its high-throughput and high yield capabilities of replicating nanostructures at the 200 mm wafer scale, this lithography system will allow to significantly reduce process and development times for INL and its partners. It will be used for a broad range of applications, covering fields in optics, nanosensors and surfaces with very special functions, to name a few.

The EITRE system is scheduled to be delivered to INL during the fourth quarter this year.
