Today EG7 announces the title Power Chord, a team-based deck-building game developed by Big Blue Bubble. Power Chord will be released on Steam Early Access (PC) in December 2021.

Currently being developed by Big Blue Bubble, the developers of the world-renowned My Singing Monsters franchise, Power Chord assembles the Earth's mightiest musicians and utilizes their unique abilities to battle against a demonic horde. With each bandmate having their own distinct gameplay style, cards and perks, Power Chord allows players to create unique combos based on different band combinations.
